Thanks for sending these. Marc and I have no significant comments to make.

The only thing I would mention is where it says, 'The footprint of the enabling earthworks will then be maintained as bare ground until works begin, to discourage birds from nesting in the area. This can be achieved using herbicide, or by regularly harrowing', would there be an alternative method other than using herbicide, as it could potentially run into nearby water sources?
