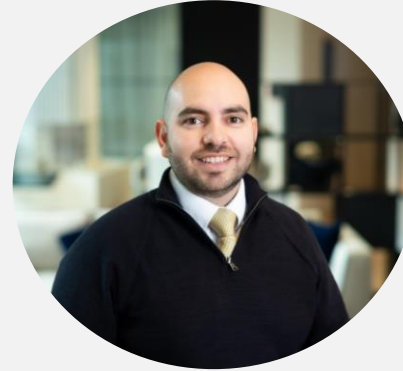

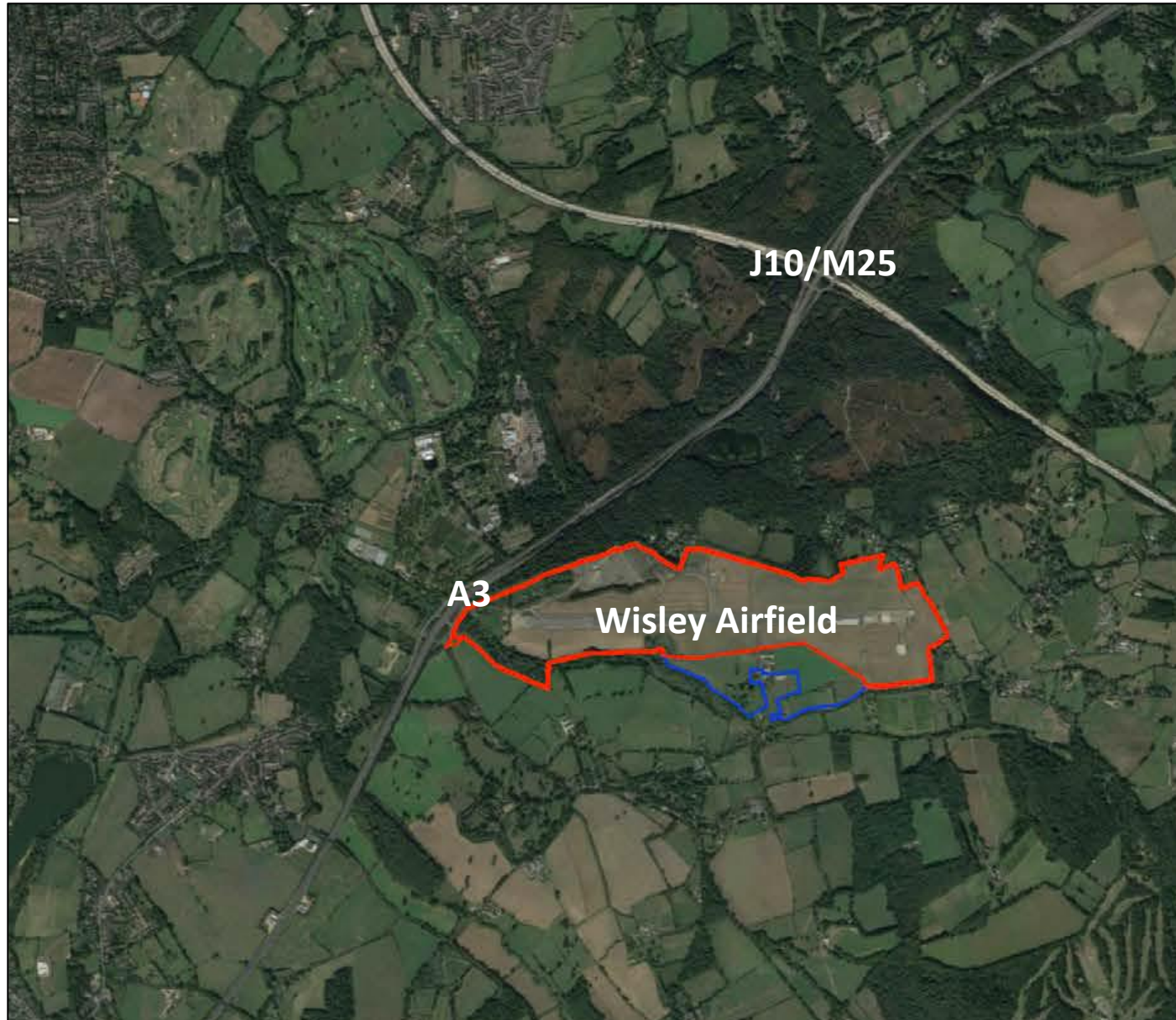

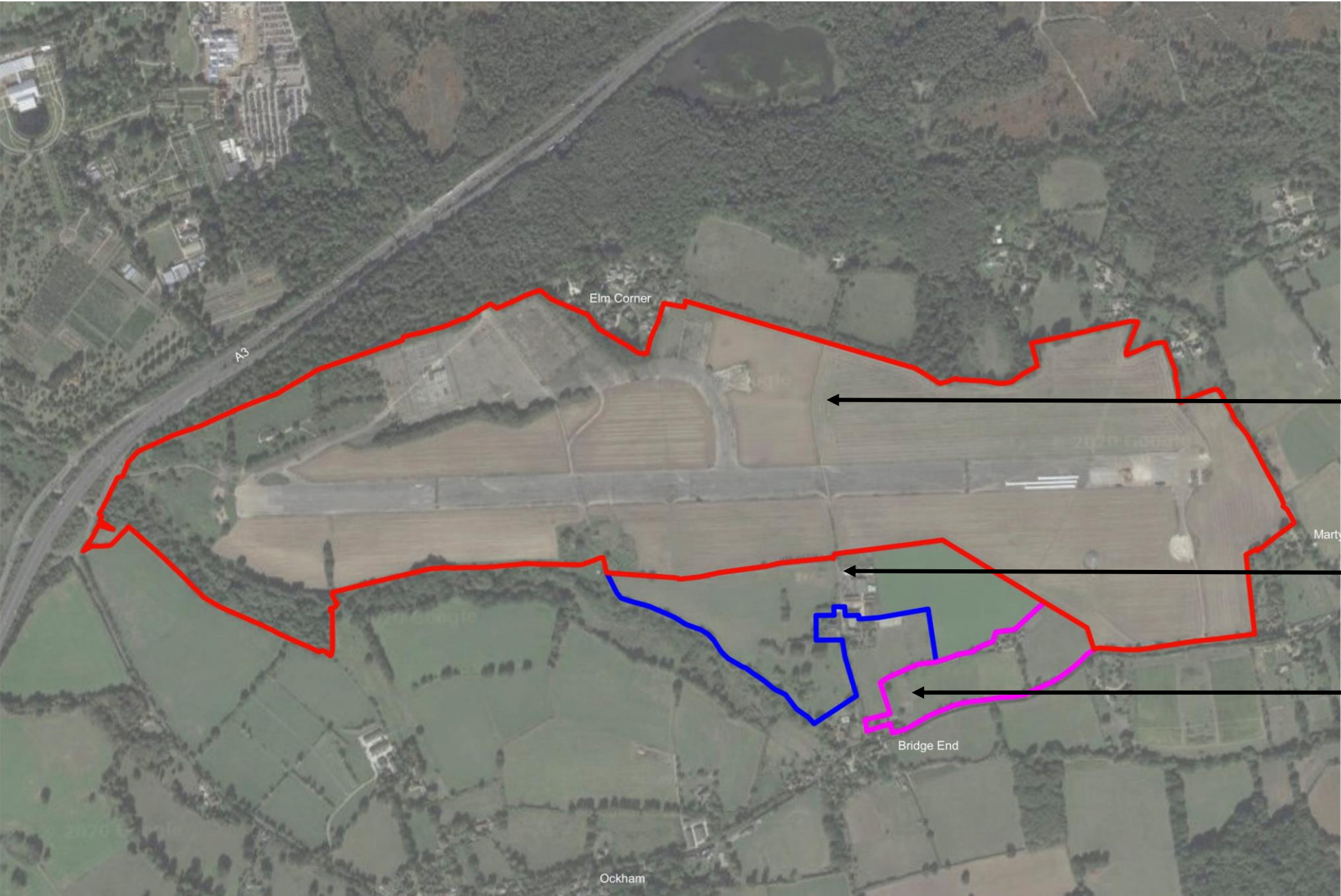


Aerial view of the former Wisley airfield from the west

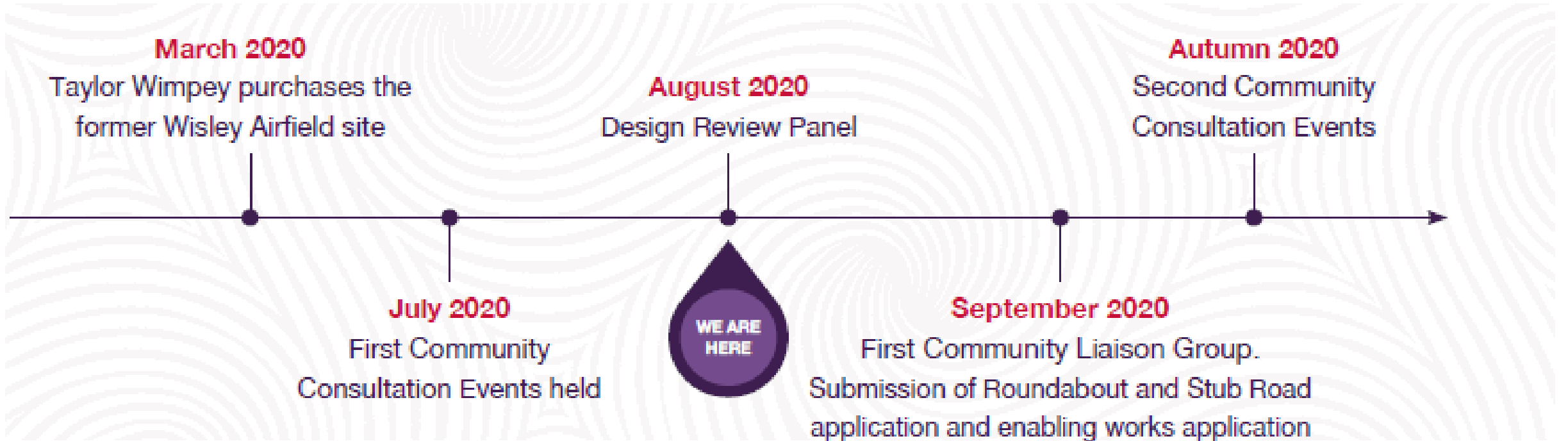

- ❑ *Membership of the group in no way implies your personal support or objection to the proposals;*
- ❑ *By accepting membership to the group you are accepting that your contributions to the group will become part of the **minutes that will be published online** after the event finishes.*
