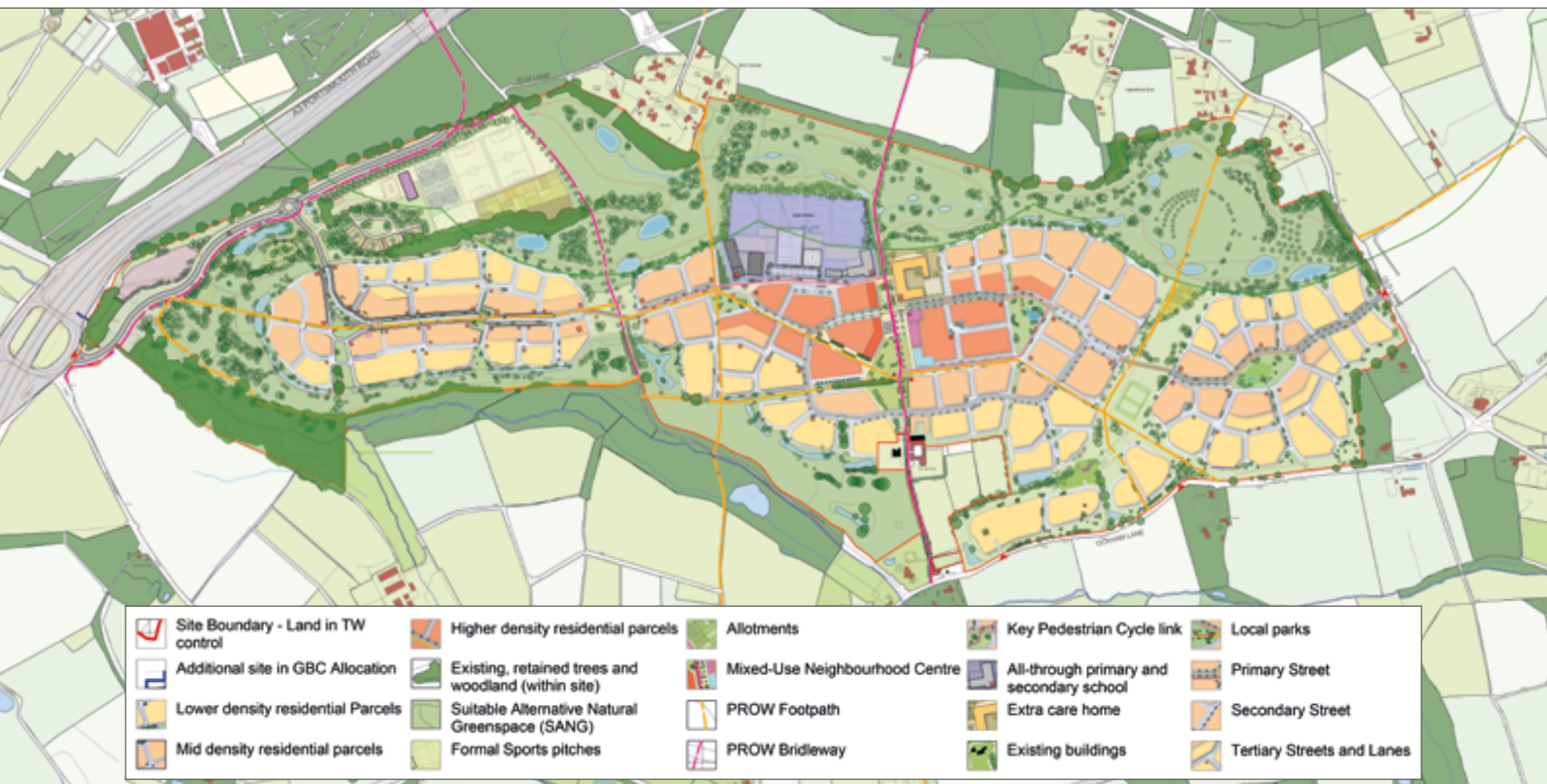

Draft masterplan as presented during our November consultation

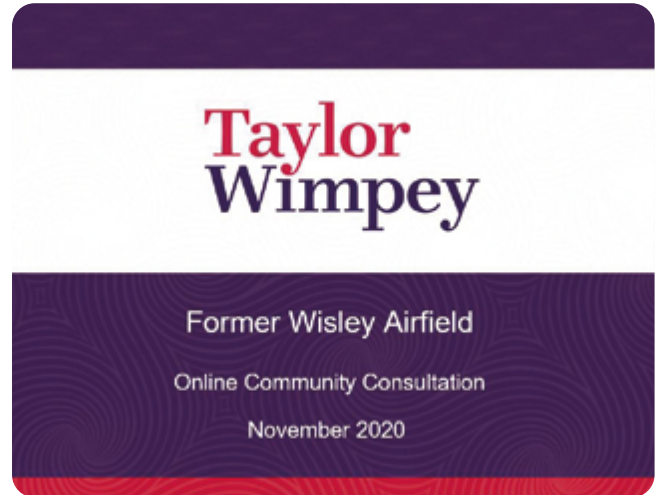
SEASON'S GREETINGS

We will continue to keep you up to date as we head towards our third and final round of consultation and submission of the application in 2021.



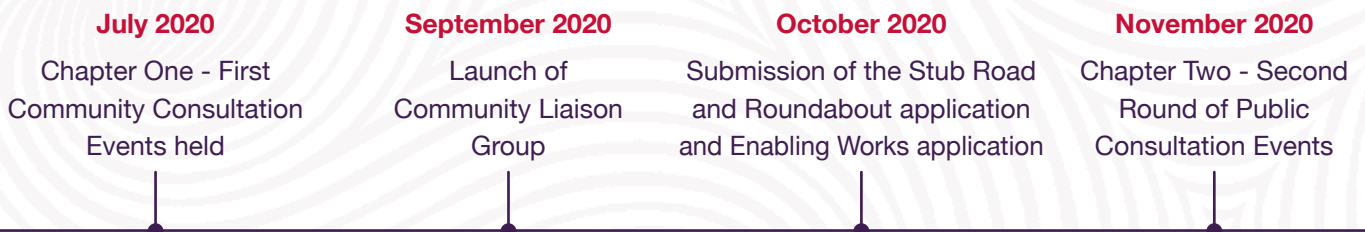

Headline Figures

- **Land ownership** - 75% (15 out of 20) of respondents were aware of all the land Taylor Wimpey owns and that they are submitting a masterplan for the whole area.
- **Stub Road and Enabling Works applications** - 76% (19 out of 25) of respondents were aware that Taylor Wimpey has submitted an application for a stub road and for enabling works.
- **Village Centre** - The most popular shops and services for the Village Centre were a smaller food shop, a cafe, a chemist/pharmacy, a butchers and a doctors.
- **Health and wellbeing** - 86% (19 out of 22) of respondents were in favour of onsite health and wellbeing facilities - of these facilities, the most popular was a doctors, followed by sports facilities.
- **Sustainable transport** - 67% (14 out of 21) of respondents agreed that sustainable transport should continue to be treated as a priority.
- **Community events and activities** - The most popular activities for the proposed Community Trust to promote included occasional events, an annual fete, sports events and faith services.
- **Green links** - 42% of respondents strongly like the green links separating the three villages in the proposed masterplan, with 37% selecting 'like' - a total of 79% (15 out of 19).
- **Horticultural trail** - 78% (14 out of 18) of respondents like the potential of a horticultural trail.
- **Sustainable transport corridor** - 84% (16 out of 19) of respondents agreed with including a sustainable transport corridor with segregated cycleways through the site.
- **Onsite and offsite cycling** - 94% (15 out of 16) of respondents felt that they understood the potential cycle lanes that could be included in the masterplan application.
- **Electric vehicle charging points** - The majority of the respondents wanted to see electric vehicle charging points in every home, on the streets and in the Village Centre and other key community areas, rather than just one of these locations.
- **Cycling routes** - The majority of respondents felt that the cycle routes should also include Cobham, in addition to those destinations listed within the draft masterplan, as well as Woking, Guildford and Leatherhead.
- **Sustainable transport modes** - The most popular modes of sustainable transport were bus, walking and e-bikes.
- **Bus service** - 70% (14 out of 20) of respondents would use a frequent, clean and reliable bus service.
- **Renewable energy** - 91% (20 out of 22) of respondents told us that renewable energy is important or very important for this proposed development.

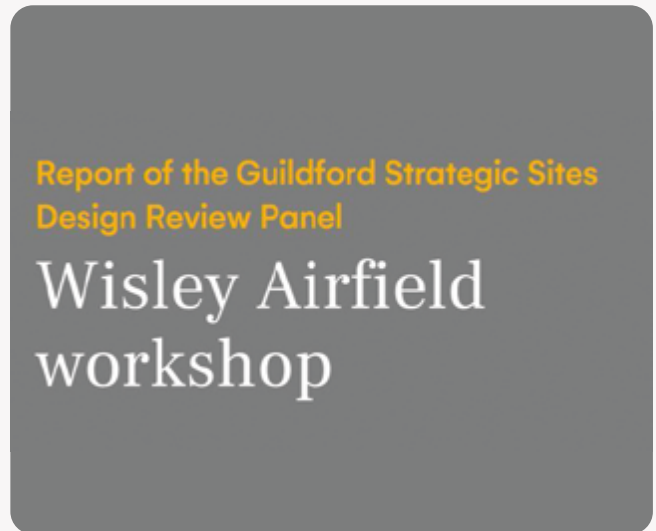
